Full Walkthrough

Below is a step by step walkthrough covering every case **Dual Destinies** and the *Turnabout Reclaimed* DLC. Follow the sections to uncover all hidden clues, master courtroom tactics, and achieve a flawless victory.

Case 1 – The Murder of the Cursed
